- For joint supervision of research students, the formula shall be **70%** of the total score for Supervisor and Co-supervisor. Supervisor and Co-supervisor, both shall get **7 marks** each.
- *For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b). Policy Document and 6. Invited lectures/Resource Person/Paper presentation shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of **three categories** out of **six categories**.
