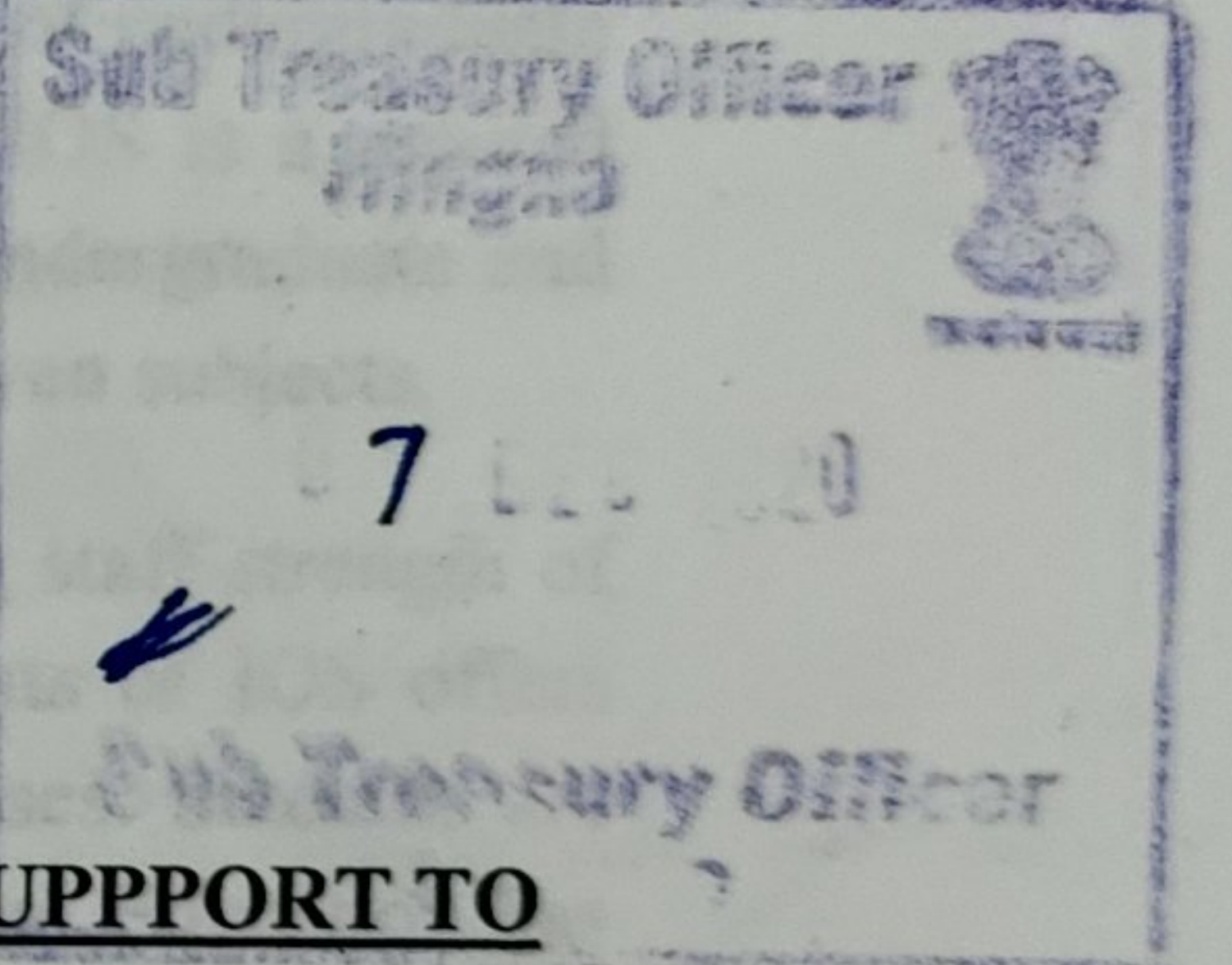

#### Article 4 Settlement of Differences




Road, Civil Lines, Nagpur, Maharashtra, India, 440008, (herein after called as 'Institute of Science', which expression shall, unless repugnant to the context or meaning thereof be deemed to mean and include its successors and permitted assigns) of the one part,

And

Nagpur Veterinary College, Futala Lake Road, Nagpur, Maharashtra, India, 440006. (Herein after called as 'Nagpur Veterinary College'), which expression shall within the context so admits include its successors and permitted assigns) of the second part.



AND

In the spirit of intellectual co-operation, scholarly exchange, and partnering with leading institutions, Institute of Science and Nagpur Veterinary College, agree to establish a program of exchange and collaboration on related matters of mutual interest on multidisciplinary research and teaching.

1. The purpose of the cooperation is to promote collaborative research and to facilitate the exchange of ideas, development of new knowledge and enhance high quality research acumen. The major thrust of the research on which the parties will co-operate is Animal studies includes Physiology, Anatomy, Pathology, Toxicology, Genetics and Epidemiology & Nutrition. The modes of co-operation will include:
  - a. Visit of faculty and students for the purpose of research and teaching;
  - b. Development and implementation of cooperative research projects, professional development programs, capacity-building efforts and co-operation in availing research regulatory requirements such as Institutional Animal Ethics Committee approvals
  - c. Dissemination of findings through joint scholarly publications.
  - d. Undertaking joint projects, exploit, commercialize and deploy intellectual property developed jointly.
2. To achieve the goals of this cooperation, both parties will
  - a) Promote institutional exchange by inviting faculty and student researchers of the partner institution to participate in appropriate research activities;
  - b) Jointly organize symposia, conferences, and meetings on timely research issues;
  - c) Develop and carry out joint research programs; and
  - d) Exchange information pertaining to the agreed-upon research areas.
3. Prior to the initiation of any particular project or activity, the specific terms of cooperation and exchange for that project will be discussed and agreed upon in writing by the appropriate responsible representatives of both the institutions.
4. Both parties understand that all financial arrangements for specific exchange activities must be mutually agreed upon and will depend on the availability of funds. In addition, the scope of the activities will be subject to funds available at the institutions for the type of collaboration undertaken and any financial assistance that may be obtained by either from external sources.
5. Either party may propose to the other specific individual research projects for collaboration. Such proposal may be made at any time and the parties will develop an agreement for each agreed-upon project.
6. Ownership of any intellectual property, including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights developed jointly during the course of this MoU shall be vested in both the Parties. The expense of filing and maintenance of intellectual property shall be borne jointly by both the parties.
7. Each Party agrees to release and hold the other harmless from and against any claims, damages, liability or costs, to the extent such claims damages, liability or costs do not arise from the negligent or willful acts or any of its agents or employees in connection with their respective performance under this MoU.
8. All publications in the programmes of co-operation will be co-authored by the concerned staff/Research Fellow of Institute of Science and Nagpur Veterinary College.
9. Both parties agree that in the course of implementing this MoU, they will not engage in unlawful discrimination on the grounds of race, gender, sexual orientation, age, religion, social class, national or ethnic origin or disability.
10. Amendments to this MoU can be made at any time after consultation and agreement between the two institutions. Any such amendment must be done in writing and signed by both the parties.
11. This MoU will remain in force initially for a period of 5 (five) years from the date it is fully executed. The MoU can also be suitably modified, as agreed to by both the parties, to reflect an increased



scope, nature of engagement /activities. In addition, either party may terminate the MoU in advance of its normal expiration by providing the other Party with three months' prior written notice. Any dispute between the parties arising from this Agreement shall firstly be settled amicably through negotiations and dialogue in good faith, failing which the same shall be referred to Arbitration at the Administration office of either Institutes at Nagpur after mutual consultation and shall be settled by Arbitration which shall be conducted in accordance with the provisions of (Indian) Arbitration and Conciliation Act, 1996 or any subsequent amendment thereof and the language shall be English. The Award shall be final and binding upon the Parties. This Agreement shall be governed and construed in accordance with the laws in India. Each party shall bear and pay its own cost of arbitration proceedings. The provision of this clause shall not become in-operative notwithstanding this agreement expires or ceases to exist or is terminated or revoked.

## Memorandum of Understanding (MoU)



This Memorandum of Understanding is entered on this 30th day of January 2024,

Between

Council of Scientific and Industrial Research, a society registered under the Societies Registration Act (XXI of 1860) and having its registered office at Anusandhan Bhavan, 2, Rafi Marg, New Delhi – 110 001 through Director, National Environmental Engineering Research Institute, having its office at Nehru Marg, Nagpur-440020 (hereinafter called as 'CSIR-NEERI', which expression shall, unless repugnant to the context or meaning thereof be deemed to mean and include its successors and permitted assigns) of the one part,

And

Institute of Science Nagpur, an autonomous Institute of Government of Maharashtra a premier institution established in 1906 affiliated to RTM Nagpur University having registered office at RT Road, Civil Lines Nagpur 440001 through Director, Institute of Science Nagpur (hereinafter called as 'INSTITUTE OF SCIENCE NAGPUR', which expression shall unless repugnant to the context or meaning thereof be deemed to mean and include its successors and permitted assigns) of the second part.



In the spirit of intellectual cooperation, scholarly exchange, and partnering with leading institutions, **Institute of Science Nagpur and CSIR-NEERI** agree to establish a program of exchange and collaboration on related matters of mutual interest.

1. The purpose of the cooperation is to promote collaborative research and to facilitate the exchange of ideas, development of new knowledge and enhance high quality research acumen. The major thrust of the research on which the parties will cooperate is Chemical Science, Environmental Science, Mathematical Science, Physical Science, Life Science & Engineering.
2. The scope of this MoU is purely for the Academic purpose only. The MoU is non-binding in nature and there will not be a financial obligation on either party. The MoU shall not be used for any outsourcing activities among the parties. The scope of this MOU is limited to Academic activities and the MOU is non-binding in nature, no financial obligations, no outsourcing activities between the parties.
3. The activities under this co-operation will include:
  - a. Promote institutional exchange of faculty and student researchers of the partner institution to participate in appropriate 'Teaching & Research' activities.
  - b. Organize Seminar, Symposia, Conferences on mutually agreed emerging areas;
  - c. To undertake research activities
  - d. To undertake Guidance and supervision of Doctoral, Post Graduate Project/dissertation work, and also trainee interns

Any of the above work is hereafter referred as '**ACTIVITY**'.

4. Prior to the initiation of any particular Activity, the specific terms of cooperation and exchange (TOR) for that activity will be discussed and agreed upon in writing by the appropriate responsible representatives with the approval of competent authorities of both institutions.
5. Both parties understand that any financial requirement for specific activities like Seminar, Symposia, Conferences etc. must be mutually agreed upon between the parties
6. The activity of institutional exchange of faculty, student, researchers and guidance and supervision of Doctoral, Post Graduate Project/dissertation work, and also trainee interns will be governed by the prevailing rules and guidelines of the host Institute. The parties will have to bear their own cost of expenses required for this activity.



7. For Research project:

- i. Either party may propose to the other party for specific individual research projects for joint research project with mutually agreed terms and conditions for funding to organization like DBT/DST. The disbursement of funds from sponsoring agency shall be individually to respective organization.
- ii. Such proposal may be made at any time and the parties will develop an project specific agreement for each project.
- iii. The Protection, Utilisation, Expenses (filing & maintenance) of any intellectual property arising out of a research project will be addressed in each project specific agreement.

8. The parties shall consult each other for any publication in respect of the activity. These publications shall be in the names of research workers from both the parties contributing to the activity.

9. Each Party agrees to release and hold the other harmless from and against any claims, damages, liability or costs, to the extent such claims damages, liability or costs do not arise from the negligent or wilful acts or any of its agents or employees in connection with their respective performance under this MoU.

10. Both parties agree that in the course of implementing this MoU, they will not engage in unlawful discrimination on the grounds of race, gender, sexual orientation, age, religion, social class, national or ethnic origin or disability.

11. Amendments to this MoU may be made at any time after consultation and agreement between the two institutions. Any such amendment must be in writing and signed by both parties.

12. This MoU will remain in force for a period of 5 (Five) years from the date it is fully executed. The MoU can also be suitably modified, as agreed to by both the parties, to reflect an increased scope, nature of engagement /activities including financial commitments, if any. Prior to the expiration date, the MoU may be reviewed for possible renewal for a further 5 years period. In addition, either party may terminate the MoU in advance of its normal expiration by providing the other with six months' prior written notice. However, for early termination of MoU, all the ongoing activities will continue till completion of commitments and obligations of the activity.

13. Any dispute between the parties arising from this Agreement shall firstly be settled amicably through negotiations and dialogue in good faith, failing which;



- a) In the event of any question/dispute /difference arising under the agreement or in connection herewith (except as to matters the decision of which is specially provided under this agreement) the same shall be referred to the Delhi International Arbitration Centre (DIAC) for appointment of Arbitrator to adjudicate the dispute.
- b) The award of the Arbitrator shall be final and binding on the parties. The Arbitrator may give interim award(s) and /or directions, as may be required.
- c) Subject to the aforesaid provision, the arbitration and conciliation Act, 1996 and the rules made hereunder and any modification thereof from time to time being in force shall be deemed to apply to the Arbitration proceedings under this clause.

This MoU has been executed in two originals; one of these has been retained by CSIR-NEERI, Nagpur and the other by Institute of Science Nagpur.


